### **At Canada Half Yearly Meeting of Friends held at Bloomfield the 12<sup>th</sup> of 6<sup>th</sup> Month 1914.**

It being considered a more suitable time and to better serve the convenience of those convened and some notice having been given to that effect, the meeting adjourned to meet at 2:30 to-morrow afternoon.

### **At Canada Half Yearly Meeting of Friends held at Bloomfield Ontario the 13<sup>th</sup> of 6<sup>th</sup> Month 1914.**

The clerk being absent the name of Filona Barker being proposed and approved, she is requested to act for the day.

The Half Yearly Meeting minute Book having been lost by theft since the last Half Yearly Meeting, it is found necessary to proceed with this meeting without reference to proceeding minutes.

The minutes of Yonge St Monthly Meeting and West Lake Monthly Meeting were read. All the representatives present except five, satisfactory reasons being given for the absence of two.

Yonge St Monthly Meeting recognising the matter of extending the franchise to women instructs its representatives to bring before the Half Yearly Meeting the request that that body forward the matter to the Yearly Meeting. After some discussion it was united that the subject be referred to the ~~Monthly~~ Yearly Meeting for its consideration and action.

The queries were read with their answers as forwarded from the subordinate meetings. A summary was adopted and directed to be forwarded to the Yearly Meeting, in care of the following friends

Having been enabled to transact the business with harmony, we now adjourn to meet at Yonge St at the usual time in ninth month next.

Answers to the Queries.

- 1<sup>st</sup> Some friends have been diligent in the attendance of our meetings for worship and discipline but conditions are not entirely satisfactory in these respects. Hour of meeting fairly well observed.
- 2<sup>nd</sup> Friends generally maintain love and fellowship as becomes our Christian profession, no differences known, talebearing and detraction discouraged.
- 3<sup>rd</sup> Friends are clear of the use of intoxicating liquors as a beverage and do use their influence toward total abstinence in their neighborhood, none known to frequent taverns or places of demoralizing tendency.
- 4<sup>th</sup> Assistance has been reasonably afforded. Attention has been given to the education of children to fit them for business.
- 5<sup>th</sup> Friends maintain a faithful testimony in favour of a free gospel ministry resting upon divine qualification and bear a testimony against war, oaths and all forms of oppression.
- 6<sup>th</sup> Friends are careful to be just in their dealings and punctual in complying with their engagements and endeavor to live within the bounds of their circumstances and to avoid involving themselves in business beyond their ability to manage, as becomes our Christian profession and when any give [...]

**At Canada Half Yearly Meeting of Friends held at Yonge St. 28<sup>th</sup> [illegible]**

Reports were received from Yonge [St.,] West Lake, and Pickering Executive. The names of the Representatives Called, and all answered except [cut off] from West Lake.

The term of the Clerks [appointed] having expired, the names of [Charles] Willson, and Filona Barker [were] proposed, united with, and they [appointed] for one year.

The Representatives appointed [to] attend the Yearly meeting report all attended and forwarded the [business] with the money as directed.

The Extracts from the Minutes [cut off] the Yearly Meeting being present, that part of one of them being [cut off] Claiming the attention of this [meeting] by which it appears the [Subordinate] Meetings are directed to raise their [cut off] of Two hundred and fifty dollars [(250.00)] [cut off] the use of that meeting.

This meetings subordinates are [therefore] directed to the observance of the [cut off] pay to the Clerks of the Half Yearly meeting and report in 5<sup>th</sup> month.

The Queries and Advices were read and deliberated upon, not [cut off] the written answers thereby [cut off] many expressions of helpful [counsel]. ~~The meeting then adjourned to meet again at 2 P.M.~~

~~About the time adjourned to, the meeting resumed the business as follows. --~~

William G. Brown, Fred Phillips, Earnest Firth, Joseph J. Brown, and Lillian Wisdom were appointed as a committee to consider and present to the next session an expression concerning the attitude of this meeting to the present crisis for its Endorsement.

The meeting then adjourned to meet again at 2 P.M. -

About the time adjourned to, the Meeting resumed the business as follows.--

When the foregoing committee made the following report.-

The devastating War in Europe and the conditions of Life and government, which have given rise to the same, has engaged our earnest attention with more than usual concern.

Our minds lovingly turn to the Friends in England especially, at this trying time, and we gratefully acknowledge the expression of their attitude in the broad visioned and weighty message

*“To men and women of Good Will in the British Empire.  
We believe our present duty lies not so much in criticism of the methods employed to end hostilities, as in prayer and effort without ceasing for the attainment of ‘Love that [cut off] out fear’ that inspires and leads us to the relief of suffering, to the employments of our talents in an examination of the conditions of [Life] and Living, of trade and Commerce, and of the real Spirit and aim [cut off] government, which have given [rise] to the violation of the righteous [relations] of men, as a preparation for service in the reconstruction period which must surely follow.”*

Now with thankfulness to [the] Divine Father for the realization of his Loving Spirit with us during the different sessions of the meeting, we now adjourn to meet at Toronto at 10 a.m. 7<sup>th</sup> day preceeding the Yearly Meeting in 6<sup>th</sup> month next.

### **Canada Half Yearly Meeting of Friends held at Toronto, 12<sup>th</sup> of 6<sup>th</sup> Month, 1915**

One of the Clerks being absent, Lydia R. Richards was appointed for the day.

Reports were received from Yonge St. Monthly and Pickering Executive Meetings.

Of the six Representatives, but two were present, an excuse given for the absence of one.

The Queries and Advices were read with answers to the former as forwarded from one Monthly Meeting which was adopted as a summary and directed to be forwarded to the Yearly Meeting by the following Representatives, Stephen K. Brown, Lydia R. Richards, Serena Hughes, Wm G. Brown.

They are also instructed to call upon the Clerk of this meeting for the money forwarded from the various meetings which was called for by the Yearly Meeting to pay the same to John Bycraft treasurer and report at our next meeting.

Wm G. Brown informed the meeting that he had forwarded to Isaac Sharp Secretary of the Meeting of Sufferings of London Yearly Meeting, the minute of Sympathy directed by our last Half Yearly Meeting and received a reply expressing their gratitude for the same.

Attention was drawn to the [use] of the term Quaker used in Commercial Enterprise which [caused] considerable discussion.

It was deemed wise to drop it for [cut off] present, with the suggestion that [cut off] might be a subject of thought.

We have been favored with the presence of visiting Friends from various other Meetings, Isaac Wilson, Elizabeth Stover, Percy Clapp, Charles A, and Rebecca Zavitz, and Willson Brown whose company was very gratifying to us.

Having realized the presence of the Divine Spirit with us, we now adjourn to meet at Yonge [Street] at the usual time in 9<sup>th</sup> month [cut off].

**At Canada Half Yearly Meeting of Friends held at Yonge St. 27<sup>th</sup> of 9<sup>th</sup> Mo 1915.**

Reports were received from West Lake Monthly and Pickering Executive Meetings, no representatives present from either. The minutes from Yonge St monthly meeting having been misdirected, were not present, and one representative reported verbally, that there

was no business which Claimed the attention of this meeting, and the representatives were all present but one.

The time for which the clerks were appointed being now expired. The name of Charles Willson and Philona Barker being proposed, were united with, and they appointed to serve in that capacity for one year.

The latter not being present, Rebecca Zavitz was appointed to assist for the day.

The representatives appointed to attend the Yearly Meeting report, they all attended with business from this meeting.

The extracts from the minutes of the Yearly Meeting being present that part of one of which claimed the attention of this meeting was read, by which this meeting is directed to raise its proportion of \$400 for the use of that meeting, pay the same to John E Bycraft, Treasurer of that meeting and report.

The Subordinate meetings are therefore directed to the observance of the same, pay to this meetings Clerks and report in 5<sup>th</sup> month next.

*[Page 12 – Canada Half Yearly Meeting (Orthodox) – Box 48 – 48-0-1]*

The Queries and Advices were read with answers to the queries as forwarded from one Monthly Meeting, there being no answers present from the other meetings.

A minute of Introduction from Whittier Fellowship committee [Riser] N.Y. held 8 of 3 mo 1915 for Margeret Jenkins a member of that meeting was read, and many expressions of appreciations by this ~~this~~ meeting were offered with thankfulness for her presence with [cut off].

A Communication from Pickering Executive Meeting was received and read, in reference to the meeting property at that place.

It was decided after some deliberation that this meeting [cut off] no authority to take any action in the matter, but refer it to Yonge [St] Monthly Meeting.

A resolution was adopted asking that the Canadian Government make such regulations as will lead to the restoration of the [family] life to the Hindustans in Canada.

A letter was read from Yonge [St] Quaterly Meeting at Pickering in which was expressed a large feeling of fellowship which was received [cut off] the same feeling of love that we feel prompted sending such a letter and the Clerks were instructed to prepare [and] forward a suitable reply, to the same, and sign on behalf of this meeting.

With Thankful hearts for the realization of the presence of the Divine spirit controlling the transaction of the business coming before us, we now adjourn to meet at Bloomfield at the usual time in 5<sup>th</sup> month next.

Reports were received from Yonge St. Monthly meeting

the representatives being called and all present excepting two. No reports were received from West Lake Monthly or Pickering Executive meetings.

The term of the clerks appointment expiring at this time the name of Filona Barker was united with and she appointed for one year, Mildred Hughes being appointed for the day.

Bring up again The communication received from Pickering Executive meeting in 9<sup>th</sup> month 1915 which directed the observance of Yonge St monthly meeting, but that meeting decided that under present circumstances they had no authority to take any action in the matter and have returned it back to the observance of this meeting which after deliberation thereon, this meeting is united in granting their request so far as we have any jurisdiction in the matter by consenting to recognize their Executive Board already appointed and their successors, as having all power to transact business, to receive and care for and apply all money now in their possession, and all that may come to them for the upkeep of that meetings property.

A very acceptable epistle of Fellowship from Yonge St. Quarterly Meeting of Friends held at Pickering 23<sup>rd</sup> of 9<sup>th</sup> month 1916 was read and greatly appreciated. Many expressions of satisfaction were spoken for the united feeling and growth of fellowship prevailing among Friends. Albert Widdifield with the clerk are appointed to frame a suitable reply to their letter.

William G. Brown, Agnes Rogers, Miriam Armitage Harry Perkins. are appointed to attend their next Quarterly Meeting, Dec. 16 at Maitland St. Toronto and present this epistle.

We have had Isaac Wilson and Elizabeth Stover with us at this meeting also Barclay Spicer of Philadelphia. The presence and services of our friends Alfred Young and Cuthbert Wigham have also been very acceptable at this time.

That portion of the Extracts of the Minutes of the Yearly Meeting was read which directed this meeting to raise its portion of the \$550.00. The subordinate meetings are also reminded to observe and pay the same as directed.

The question of the use of our Meeting Houses having been brought before the meeting and discussed, this meeting advises the subordinate meetings to take the matter into consideration.

**At Canada Half Yearly Meeting of Friends held at Bloomfield, 6<sup>th</sup> Month 9<sup>th</sup> 1917.**

The Minutes of the last Half Yearly Meeting were read and approved with some slight changes and additions to be made by the Clerk

Reports were received from Yonge St. and West Lake Monthly Meetings. Representatives were all present except two from Yonge St, satisfactory reasons being given for the absence of both.

~~An epistle of fellowship from Yonge St Quarterly Meeting held at Newmarket 2<sup>nd</sup> month 17<sup>th</sup> was read and accepted in the spirited in which its message was conveyed and after kindly expressions of unity, the clerks are directed to essay a reply.~~
