# Pelham Register, Book B

# Catalogued as a marriage Register, 1807 - 1906 Includes births and a few deaths from 1739 - 1857

This Register is held by the Canadian Quaker Archives and Library in Newmarket, Ontario. It has been microfilmed and is available at the Archives of Ontario, MS 303, reel 42. The Register was not given an Hicksite "H" code by Arthur Dorland. It is catalogued as Pelham Book "B" (marriage Register), 1807-1906.

However, the Register is more than the catalogue title implies. It is really two registers in one. The pages were mostly numbered in the original. The first 50 pages are marriages in mostly chronological order from 1797 to 1817 then from 1850 to 1906. Then a second set of numbered pages begins recording births and a few deaths from 1739 to 1857. This second set of pages may have come from another book and then bound together into one register. This register was begun before the separation in 1828. The Hicksites kept and continued to use this register.

This transcription was completed by Carm Foster and formatted for posting by Randy Saylor and is posted on the Canadian Friends Historical Association (CFHA) web site. It is made freely available and supports search, cut and paste. CFHA will officially grant linking privileges to organizations that support this free access. CFHA wishes to express its gratitude to those who worked on this project.

The text was transcribed as written, so researchers must consider the many variations in spelling when searching the transcribed text. Transcriber notes are in square brackets. The book has not been proof read. Several pages have not been transcribed due to very faint image quality. These pages are indicated as such. An effort is being made to retake these pages and update this register.

By the mid 1790's a number of Quakers, mostly from Pennsylvania, had settled in the Niagara area. In 1799, the Philadelphia Yearly Meeting approved the establishment of Preparative meetings at Short Hills in Pelham Township and Black Creek in Bertie Township and one day later Pelham Monthly Meeting was established. The meeting house was rebuilt to be larger in 1807. In 1810 the Canada Half Yearly Meeting was established under New York Yearly Meeting with Pelham, Yonge St and Adolphustown being the Monthly Meetings. Norwich became a Preparative Meeting under Pelham in 1816. Upon the separation in 1828, the Hicksite branch of Pelham came under Genesee Yearly Meeting in 1834.
